अतः दी रोड ट्रान्सपोर्ट कॉरपोरेशन्स एक्ट, 1950 की धारा-38 (1)-सह-पठित धारा-38 (3)(ए) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए बिहार राज्य पथ परिवहन निगम के अधिक्रमण अवधि को दिनांक-01.04.2016 से दिनांक-31.03.2017 तक के लिए विस्तारित किया जाता है।


