Furnishing of compliance report relating to the directions of Committee on Road safety sought by its letter dated 28th December 2015.

The compliance report on the implementation of the directions issued by Committee on Road Safety, vide its letter no. 30/CORS/2014 dated 28.12.2015, is as follows:

01.	Translate the intent of the "State Road Safety Policy" into the Action Plan i.e. set targets for reduction of road fatalities, injuries and accidents to be achieved through the Policy; draw up the stategy and the road map of activities to be undertaken in a set timeframe to achieve those targets; set year-wise targets for each of those activities, keeping in view their inter se priorities; assess the resources, human and financial, required to achieve those targets in respect of each aspect. activity of Road Safety and incorporate them into the Action Plan. 02.	The State Road Safety Authority, proposed to be established by the State, should initially be set up under an executive order pending finalization and passage of the concerned statute by the State Legislature. It should also provide for setting up of the Lead Agency, duly supported by adequate dedicated professional staff, functioning on full time basis. The relevant Office Order or Notification etc in this regard should be endorsed to the Committee.	In the above mentioned meeting, Bihar Road Safety Council was authorized to function and exercise the powers of Road Safety Authority / Road Safety Traffic Management Board as recommended by the Sunder Committee.

O3. Action Taken Report on the minutes of the meeting of the Council held on 22.04.2015.

Action taken on the minutes of the meeting of the Council held on 22.04.2015 is as follows:-

- (i) Bihar Road Safety Policy, 2015 was finalised & implemented on 29.07.2015. It was also submitted to the Committee for informed vide letter no. 3751 dated 29.07.2015.
- (ii) For Bihar, Black Spots have been defined. It has also been decided that road section categorically speed over 200m in urban areas, 400m in suburban areas and 600m in rural areas, junction or a spot having 10 accidents in a calendar year shall be declared as Black Spots. This definition was also accepted by all the stakeholders and members of the Bihar State Road Safety Council in the meeting held on 3.05.2016.

(iii) The details of Road Safety Audit have been included in the BSRAP.

(iv) Driving Training courses are already running in all the ITIs of Bihar.

(v) The Institute of Driver Training & Research (IDTR) is under final stages of completion.

(vi) The Road Construction Department (RCD) and Rural Works Dept., Govt. of Bihar have initiated the process of installing road safety signage at appropriate places.

(vii) Highway Patrolling by Police has been initiated in selected places and proposal for creation of a separate wing for this purpose is under process.

(viii) Current status of the trauma centre has been discussed in para no. 14.

(ix) Govt. of Bihar has banned selling of liquor from 1st April 2016.

(x) 14 New Bus stoppages have been proposed by the Bihar State Road Transport Corporation.

- (xi) Removal of Encroachment is a continuous process. Letters have been issued to all District Magistrates for removal of encroachments. A similar letter has also been issued by the CID to all SSP and SPs.
- (xii) Department of Transport is the designated nodal dept. Land has been identified for Traffic Park. The Transport Department has recently been authorized

		to construct the park.
