(i) the approved fare-table and time-table of the routes shall be exhibited in the vehicles and on the parking places/stands and halts specified in the application for permit.
(ii) the arrangements specified in the application for the permit, for housing,maintenance and repairs of the vehicles, and for storage and sage custody of luggage and goods will be maintained.
(iii)the records and returns shall be submitted to the Transport Authority as specified by it.
 - (c) This permit is further subject to other conditions attached to the permit.
 - (d) The State/Regional Transport Authority may, after giving notice of not less than one month.
(1) vary the conditions of the permit (ii)attach to the permit further conditions.
 - (e) The permit is valid if and only if acompanied by an authorisation slip indicating the period of validity on the basis of payment of Motor Vehicle tax & additional M.V. Taxes.
 - (f) The permit is issued subject to the condition that difference of tax, if any on final calculations,shall payable along with penalty, if chargeable
 - (g) Minimum two seats shall be kept reserved for disabled passegers and shall ensure provision of low foot-board for easy accessibility.
 - (h) Every vehicle owner will keep reserve two seats of the first row for the handicap persons. It will be mentioned near the the reserve seats. Vehicle owner shall be ensure and arange wheel chair for the convinience of the handicap persons.
 - (i) Eave teasing is done by the passengers or persons in the public passengers vehicle. If such incident is reported by the victim or the co-passengers to the vehicle squad then the vehicle squad shall report to the nearest Police Station immediately. If it is not done by the vehicle squad then permit will be cancelled.
